

## Official Rules – Nuggies "Color the Cover" Coloring Contest

- 1 Entry Period. Nuggies "Color the Cover" (the "contest") begins April 23rd, 2016, at 8 a.m. MDT, and ends May 29th, 2016, at 8 p.m. MDT.
